This bachelor thesis investigates the feasibility of establishing a waste transfer- and recycling station in Gaborone. The thesis aims to support the Environmental Impact Assessment (EIA) that has to be conducted before the station can be constructed, with the cooperation of Västerås City, Vafab Miljö AB in Sweden and GCC in Gaborone.

Is Gaborone a good city for waste management?

Gaborone, the capital of Botswana, is striving to find a better solution for effective waste management. Therefore, a cooperation between GCC and the Swedish operators Västerås City and the company Vafab Miljö AB has been established.

How to access the Gaborone Technical College?

The Gaborone Technical College is located on the opposite side of the site. The site can be entered from the main road, A1, and can be connected to the existing road network. Access to the Gaborone Technical College is possible through the site.

Could a transfer-and-recycling station be a solution to Botswana's waste management problem?

Waste management is a growing problem in Botswana's capital Gaborone. A potential solution is to establish a transfer- and recycling station there which could serve as an important part in the aim to create a well-organised waste management system.
