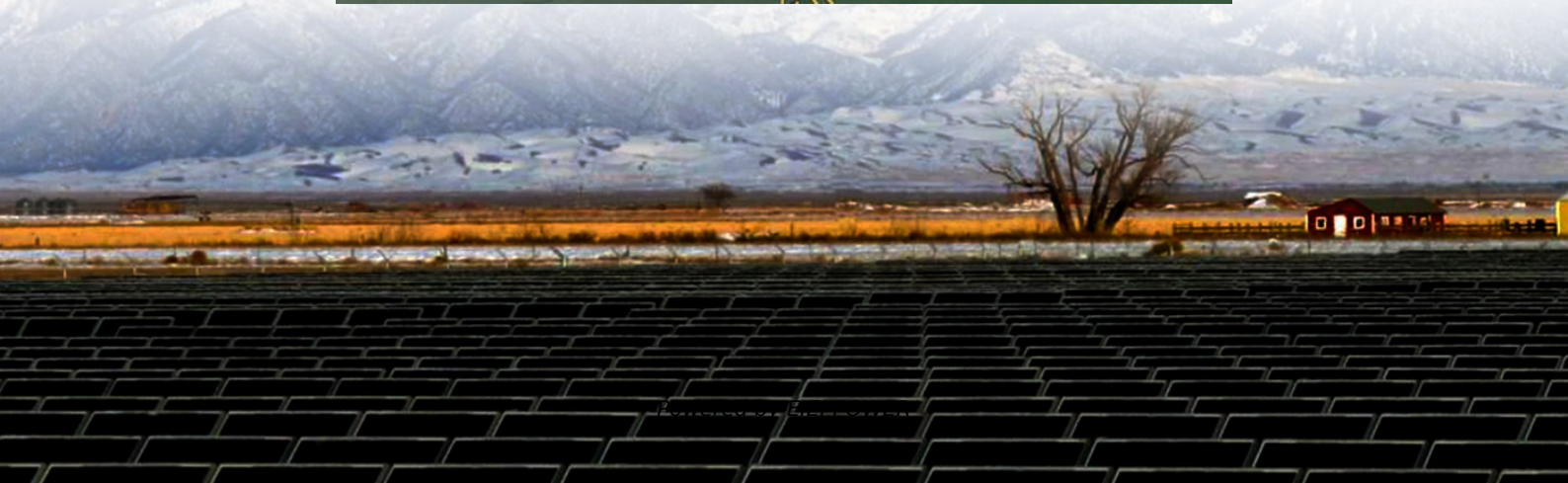

What type of energy is used in Hungary?

Biomass energy: Biomass energy, particularly from wood and agricultural waste, plays a significant role in Hungary's renewable energy mix, accounting for around 60% of the country's total renewable energy consumption.

Geothermal energy: Geothermal energy is gaining traction in Hungary, with several projects under development.

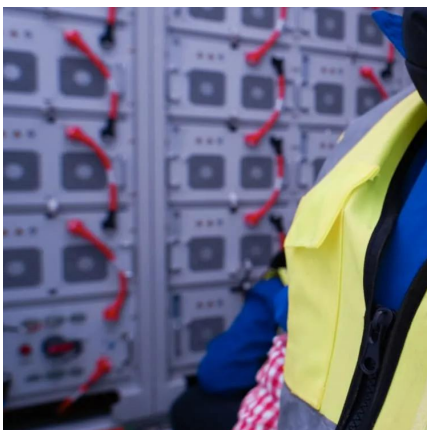

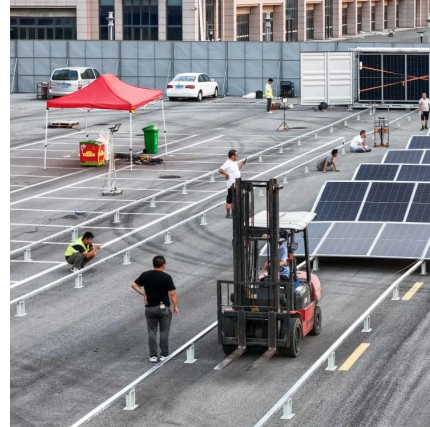
