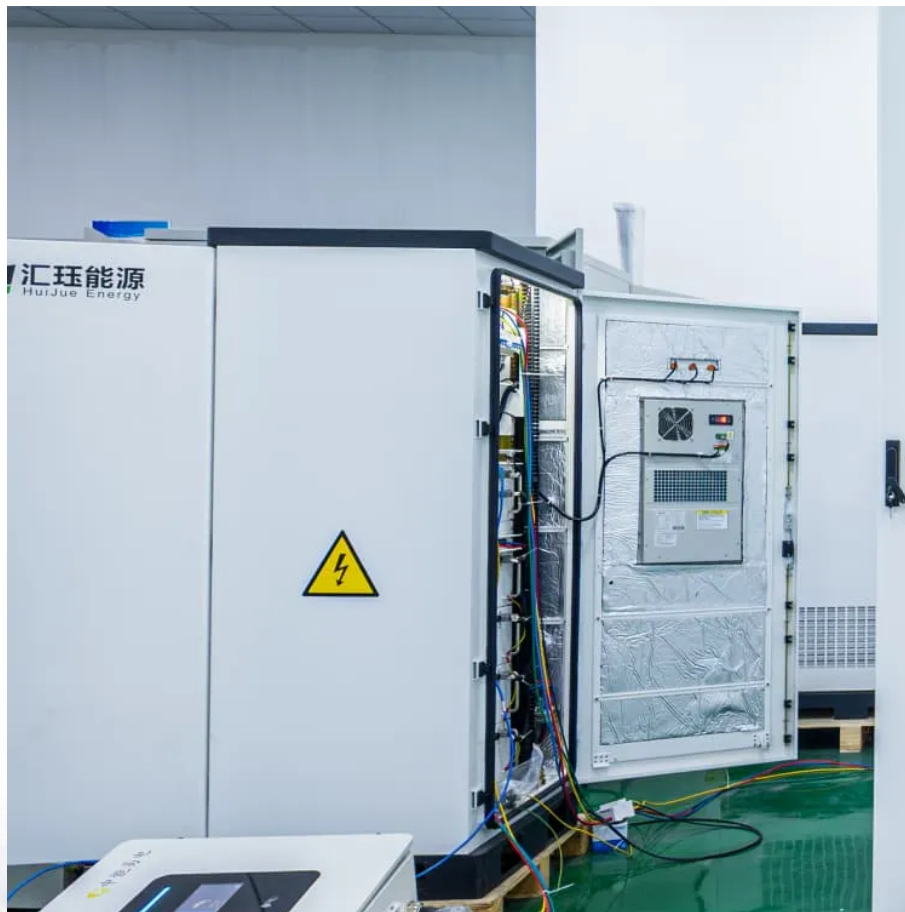

Container transportation Even though Battery Energy Storage Systems look like containers, they might not be shipped as is, as the logistics company procedures are constraining and heavily standardized. BESS from selection to commissioning: best practices³⁸ Firstly, ensure that your Battery Energy Storage System dimensions are standard.

What should be included in a contract for an energy storage system?

Several points to include when building the contract of an Energy Storage System:

- Description of components with critical technical parameters: power output of the PCS, capacity of the battery etc.
- Quality standards: list the standards followed by the PCS, by the Battery pack, the battery cell directly in the contract.

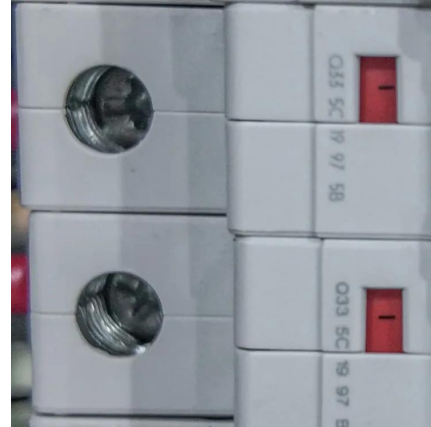
