Importers are required to pay applicable customs duties and taxes based on the Cost, Insurance, and Freight (CIF) value of the goods. Upon successful inspection and payment, IRICA issues a release order, allowing the goods to enter the Iranian market.

What is the VAT rate in Iran?

Although the VAT rate remains at 9%, its broader application will impact many foreign companies. All businesses must file taxes through the Iran Tax Automation System (ایران مالیاتی جامع سامانه). Failure to comply will result in fines up to 20% of the tax owed. The government has tripled its audit budget, focusing on high-risk industries.
